2. Age, qualification and experience possessed by the applicant **as on the closing date** of the notification only will be considered. Initial verification and short listing of applicants will be based on the details provided in the application and the copies of the documents uploaded.** Original certificates shall be submitted for verification at the time of joining. - Shortlisted candidates only will be eligible for the written test/skill test/interview.
